## CLUB FORBES – MEMBERS DRAW JACKPOT – TERMS & CONDITIONS

The Members Draws consists of two opportunities to win a prize every Wednesday, Friday and Sunday the "Members Draw Prize." This promotion is an ongoing club promotion.

## 1. GENERAL TERMS & CONDITIONS

- 1.1. Directors, Management, Staff & Promotional Contractors of Club Forbes are ineligible to enter.
- 1.2. Open to all financial members of Club Forbes over the age of eighteen (18) years who are not suspended or cited from the venue.
- 1.3. In unforeseen circumstances management have the right to cancel or postpone the cash draws at any time.
- 1.4. To claim any prize, members must produce their membership card as proof of current membership and/or one other form of valid identification. Valid ID includes Driver's License, Proof of Age Card & Pensioner Card.
- 1.5. All members financial as per Club Forbes' membership system at 6pm on Friday will be eligible for the draws.
- 1.6. If proposed prize money is greater than \$2,000 the prize winner may be paid the amount exceeding \$2,000 by EFT at the discretion of Club Forbes. EFT payment method will be completed within seventy two (72) hours of the draw.

## 2. MEMBERS BADGE DRAW JACKPOT PRIZE TERMS & CONDITIONS

- 2.1. A random number generator (membership program) is programmed to draw a membership number from the current financial club membership listing, as of the date of the draw.
- 2.2. The draw will be conducted on Wednesday, Friday and Sunday at 5:30pm and 8:30pm.
- 2.3. The holder of the membership number drawn must be in the Club at the time of announcement, and they then have four (4) minutes to claim their prize. They must present their membership card or acceptable identification to claim the prize.
- 2.4. If the 5:30pm draw prize is unclaimed, a further draw is conducted at 8:30pm.
- 2.5. The initial starting prize is \$1000.00. If the initial starting prize is unclaimed the amount will then increase the following week(s) by \$200.
- 2.6. The maximum prize is \$10,000.00.
- 2.7. If the jackpot draw is won at 5:30pm there will be no further jackpot draws.
- 2.8. Once the jackpot reaches \$10,000.00 it will remain at \$10,000.00 until it is claimed.
- 2.9. After the jackpot has been won, the prize will start at \$1000.00 the following Friday.

## 3. GENERAL TERMS & CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS

- 3.1. The Club's premises are as determined by the Club in its discretion and comprise all areas within the main club building (excluding function rooms if in use for a private event at the time of the draws). The Club's car parks does not form part of the Club's premises for the purposes of Club promotions.
- 3.2. The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions and in a form reasonably required by the Club, in order to be paid a prize.
- 3.3. The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond

- the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club's rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.
- 3.4. The Club's decisions in relation to the promotion may be made by the Club's CEO or his delegate or delegates from time to time (who may but need not be a Club executive), including decisions in relation to the appointment of a judge or judges in relation to the promotion or a particular draw or draws. The Club's CEO also may (but is not obliged to) appoint one or more scrutineers for a particular draw or draws or all draws or a prize process or all prize processes. - 3.6. Further, the Club is not responsible for members being located in areas within the Club's premises in which PA announcements are not able to be heard, nor for the audible integrity of those announcements.
- 3.7. A prize will not be awarded or paid where in the Club's reasonable opinion it arises as a result of a machine or other technical malfunction.
- 3.8. The Club has no liability for acting on or promulgating any incorrect or inaccurate information, due to any error to any equipment or programming associated with or utilised in the promotion or any technical error or error by any third party.
- 3.9. Prizes are strictly not transferable or negotiable.
- 3.10. If the Club in good faith awards or pays a prize to someone appearing to the Club to be the prize winner, then to the maximum extent permitted by law that award or payment fully discharges the Club from all liability to the actual prize winner in relation to that prize.

- 3.17. All risks of loss of or damage to any prize consisting of a car or other goods, pass to the winner immediately the Club delivers the prize to the winner. - 3.21. The value of any prize (if stated) is only an approximate retail value in Australian dollars at the date the promotion is first launched.
